This Agreement amends and modifies the existing Subrecipient Agreement (“Agreement”) dated May 3, 2021, and amended October 12, 2023, made and entered into by the parties hereto as follows:

Attachment A of the Subrecipient Agreement has been amended to reflect a CDBG-MIT award increase as previously approved on August 14, 2024, by the Mitigation Special Case Panel for an additional \$1,547,500.00 in CDBG-MIT funds provided by SCOR, and a local cost share of \$250,000 provided by the City, for a revised project total of \$3,631,775.00 as detailed in the table below.
